As guest of Elevenpark Playhouse I herewith undertake the following individual liability declaration in my own name and in the name of all minor group members:

1. Acceptance of Elevenpark Playhouse GTC

I confirm that I have reviewed and accept the General Terms of Business of the operator company ([Elevenpark Új Buda Center](#): Elevenpark Kft.) related to the Elevenpark Playhouse.

2. Acceptance of [Elevenpark Playhouse house rules](#)

I confirm that I have reviewed and accept the house rules of the Elevenpark Playhouse. I undertake that we will use the Elevenpark Playhouse at all times in accordance with the house rules and the individual game rules and in accordance with its designation in line with each person's personal physical and mental abilities.

I have understood that Elevenpark Playhouse is not carrying out nursing. In particular, I know and accept that children accompanying me may stay in the park only with my constant supervision as an adult. The liability for the children stays however at any time with me as escort.

3. Stable physical and mental status

With total awareness of my liability I declare that we are not under influence of alcohol, drugs, narcotic drugs other mind-altering substances and that we do not suffer of any disease that would hinder us in the use of the park in accordance with its designation or that would cause disproportionate danger to us, third persons or to the Elevenpark Playhouse. I also declare that we have the physical and mental status necessary for the (age-related) responsible use of the Elevenpark Playhouse, in particular we have the appropriate discipline, self-assessment and risk assessment.

4. Further use instructions on site

I acknowledge that some of the games & equipment have additional instructions on site. I undertake that we will look out for such additional instructions and we will follow them.

5. Acknowledgement and mitigation of dangers; Responsible use; Use at escort's risk; Bearing of damages

I am aware of the fact that the use of Elevenpark Playhouse itself bears accident risks and bears increased accident risk in case we are overestimating our personal physical and mental abilities and thus do not use the games in accordance with its designation. I undertake that we will avoid any disproportionate danger. I undertake to report any actions of third parties causing disproportionate danger. I undertake that we will watch out for other players, guests at all times. I undertake that we will use the Elevenpark Playhouse at all times in accordance with the house rules and the individual game rules and in accordance with its designation in line with each person's personal physical and mental abilities.

In this regards I not only shall, as necessary, help (reading, explaining, showing), but also remind and train the children escorted by me. I will at all times previously make sure whether the respective game is suitable for the child or not. I will constantly make sure the children escorted by me stays physically and mentally concentrated during playing at all times. I have understood that as a main rule, the animators and other staff do not carry out any supervision tasks, except at the designated functions (e.g. locking the TOPPAS rope).

I accept that we use the games and equipment at my risk as escort. I understand and accept that the liability of the operator of the Elevenpark Playhouse may only arise in case the condition of the games & equipment does not meet the regulations pertaining to their safe and designated use. I will report and reimburse any damages caused by us.

6. Assumption of liability as guide

I acknowledge that as an adult escort I am liable for the persons listed above in all directions.

7. Observance of instructions

I undertake that we will observe the instructions given by the Elevenpark Playhouse team in written or oral form at any rate. I accept that in case of violation of the house rules or not following any of the instructions we may be expelled from the Elevenpark Playhouse without any ticket fee reimbursement or other compensation.

8. Administration of claims

I have understood and accept that because for liability insurance reasons I have to report any damage claims on one hand immediately on site (next to taking an accident minutes), on the other hand by determining and quantifying my claims within 6 (six) months in writing.

9. Declarations in the name of the accompanied persons

I hereby declare that I am authorised to assume the above-mentioned obligations also in the name of the above-mentioned persons. In case the consent or proxy of any parent(s) is necessary, I have in my own interest obtained such consent/proxy in advance. Thus, I assume the above-mentioned obligations also in the name of the above mentioned persons.
